Opening of Regular Session

Chairman Black called the meeting to order with the Pledge of Allegiance.

Agenda Adjustments

Vice-Chairman Reckhow added a closed session to the end of the meeting regarding a personnel matter.

Chairman Black moved agenda item No. 5, "Report From "5 Yes! For Durham's Future" Communications Committee," to follow approval of the minutes. She also moved item No. 11, "Report From Tax Administrator on Revaluation," to follow the consent agenda.

Minutes

Vice-Chairman Reckhow moved, seconded by Commissioner Heron, to approve the June 11, 2001 Budget Worksession, June 11, 2001 Hearing on Possible Removal of ABC Board Members, June 11, 2001 Regular Session, June 14, 2001 Worksession, and July 2, 2001 Worksession Minutes of the Board as submitted. The June 4, 2001 Worksession, June 6, 2001 Budget Worksession, and June 25, 2001 and Regular Session Minutes of the Board were approved as corrected.

The motion carried unanimously.

Commissioner Heron stated that, for the record, the June 11, 2001 Hearing on Possible Removal of ABC Board Members Minutes included letters from two ABC Board members. She reviewed the ABC Board's travel policy and determined that the accountant is not required to bill board members for spouses' expenses. The policy plainly states that if the travel exceeds actual expenses, the employee will <u>submit</u> a check or cash for the amount due. Commissioner Heron wished to clarify this because accusations in Ms. Williams' letter weren't correct regarding the travel policy.

Report From "5 Yes! For Durham's Future" Communications Committee

John Burness, Senior Vice President for Public Affairs and Government Relations at Duke University, and Phail Wynn, President of Durham Technical Community College, have organized a committee of local business people and concerned citizens who are supporting Durham County's \$74.4 million bond referendum.

The committee is currently recruiting volunteers, developing communications strategies, and raising private funds to finance the campaign. The goal is to ensure that the entire package passes in November. Mr. Burness and Dr. Wynn reported on the committee's progress thus far.

<u>County Manager's Recommendation</u>: Receive the report on the work of "5 Yes! For Durham's Future" as provided by Mr. Burness and Dr. Wynn.

Chairman Black thanked Mr. Burness and Dr. Wynn for taking the leadership on this initiative. She asked that the Commissioners commit to speaking at several of the committee's presentations to inform citizens about the five issues in the bond, to explain the tax issue, and to answer other questions as well.

Each Commissioner agreed to make the commitment.

Chairman Black also asked the County Manager to make a commitment for staff to work with the Commissioners in whatever capacity they can.

Vice-Chairman Reckhow requested that the County Manager relay to the delegation that it must take responsibility in finding a way to replace funds that have been removed from local governments.

<u>Dr. Lavonia I. Allison</u>, 1315 Mclaurin Avenue, Durham Committee on the Affairs of Black People, voiced that the committee agrees with 70 percent of the bond referendum (four of the five issues). She also spoke about the inequities that have existed among students for years.

PROCLAMATION

WHEREAS, Lincoln Hospital, incorporated in 1901, began operations in a frame building located at Proctor Street and Cozart Avenue; and

WHEREAS, following a request from Dr. A. M. Moore, Mr. John Merrick, and Dr. Stanford L. Warren, Mr. Washington Duke donated an initial gift of \$8,550 to establish a hospital for the African-American community; and

WHEREAS, from humble beginnings and limited resources, Lincoln Hospital began a history of providing outstanding medical services, gaining much public support in the process; and

WHEREAS, in November 1924, a second hospital was completed from funds donated by the Duke family and contributions raised from private citizens as well as the Durham City and County governments; and

WHEREAS, with a \$2-million bond referendum Lincoln further expanded its facilities in 1950, and continued to serve the African-American community by providing top notch healthcare and training for generations of nurses and physicians; and

WHEREAS, the focus of the institution changed in 1976 following a merger between Lincoln Hospital and Watts Hospital, resulting in the current Lincoln Community Health Center; and

WHEREAS, Lincoln provides outstanding medical services today, continuing a legacy that will be perpetual through its patients, nurses, physicians, staff, and community supporters:

NOW, THEREFORE, BE IT RESOLVED that we, the members of the Durham County Board of Commissioners, do hereby proclaim Saturday, August 18, 2001 as

"LINCOLN HOSPITAL CENTENNIAL DAY"

THIS matter coming on to be heard and being heard before the Board of Commissioners for the County of Durham at its August 6, 2001 meeting upon petition for a refund of excise taxes paid to the Register of Deeds of Durham County. Based on the testimony presented at the hearing and on the evidence presented, the Board makes the following FINDINGS OF FACT:

- 1. On or about January 24, 2001, the Petitioner caused a deed to be recorded in the Register of Deeds Office on which excise taxes were paid in the amount of \$3,600.00.
- 2. The excise tax was paid in error as the transaction was except from excise taxes pursuant to G.S. § 105-228.29(6).
- 3. The amount of the excise taxes which were retained by the County as its share of the excise taxes was in the amount of \$1,800.00.
- 4. The deed has been re-recorded in the Durham County Register of Deeds Office on August 6, 2001 showing that no excise stamp tax is owed for the transaction.

Based on the foregoing findings of fact, the Board makes the following **CONCLUSIONS OF LAW:**

- 1. The Board of Commissioners has jurisdiction over this matter.
- 2. The Petitioner is entitled pursuant to G.S. § 105-228.37 to a refund of the County's share of the excise stamp tax in the amount of \$1,800.00.

IT IS THEREFORE ORDERED:

- 1. The Finance Officer for the County of Durham shall pay to the Petitioner the sum of \$1,800.00 as a refund of the excise stamp tax erroneously paid.
- 2. The Clerk to the Board of Commissioners shall send a copy of this Order to the Secretary of Revenue for the State of North Carolina.

<u>Consent Agenda 4(1)</u>. Addendum to Durham County Solid Waste Management Plan Update (adopt the resolution to approve minor revisions to the 10-year comprehensive plan).

The Department of General Services requested that the BOCC adopt a resolution approving minor revisions to the Durham County 10-Year Comprehensive Solid Waste Management Plan (SWMP).

On June 26, 2000, the BOCC approved a three-year revision to the 2000-2010 SWMP as required by General Statute § 130A-309.09A(b). On June 8, 2001, the North Carolina Department of Environment and Natural Resources informed Durham County that the Solid Waste Section had completed its compliance review and recommended the following areas be addressed:

- 1. Identify alternate facilities permitted to accept Construction and Demolition (C&D) waste generated within the County.
- 2. Identify alternate facilities permitted to accept Land Clearing and Inert Debris (LCID) generated within the County.
- 3. Provide a list of potential debris management sites for handling large volumes of disaster-related waste, staging areas for processing and management of the waste, and contracting for clean-up activities with the County.

In response to this request from DENR, the Department of General Services prepared an update to the SWMP for BOCC approval.

The addendum and resolution follows:

ADDENDUM TO DURHAM COUNTY 2000-2010 SOLID WASTE MANAGEMENT PLAN UPDATE DURHAM, NORTH CAROLINA

1. The following is a replacement for Part V, Section G of the Plan Update. New information is highlighted.

Part V. SOLID WASTE MANAGEMENT METHODS:
ASSESSMENT OF PROGRAMS AND DESCRIPTION OF INTENDED ACTIONS

G. <u>Disposal of Solid Waste</u>

Current Program: The Durham County Landfill closed on December 1984. The facility has been converted to the Durham County Sheriff's Office obstacle course and firing range. Private contractors collect and haul residential waste generated in Durham County to the Durham City Transfer Station on East Club Boulevard. Solid waste generated at the County's convenience centers is also transported, under contract with BFI, to the City Transfer Station.

<u>Land Clearing and Inert Debris (LCID)</u> waste generated in Durham County will typically be taken to the City LCID Landfill (Permit # 32B) located at 1833 Camden Avenue. The point of contact with the City is Nancy Newell at (919) 560-4381. However, if extraordinary circumstances dictate a need to utilize other facilities, the following LCID contacts have been established:

- Currin Landfill (Permit #32D) at Coley Road, Durham NC. The point of contact is Allan or Glenn Currin at (919) 876-1138.

However, if extraordinary circumstances dictate a need to utilize other facilities, the following contacts have been established:

Intended Actions: Durham County's plan is to continue handling the disposal and transfer aspects of the solid waste program in the current manner. Construction and demolition waste will continue to be managed at the City and other state permitted construction and demolition landfills.

2. The following is a replacement for Part VI, Section E of the Plan Update. New information is highlighted.

Part VI. EDUCATION, SPECIAL WASTES, ILLEGAL DISPOSAL, AND PURCHASING: ASSESSMENT OF PROGRAMS AND DESCRIPTION OF INTENDED ACTIONS

E. Disaster Response

Current Program: The City and County of Durham have a joint Emergency Operations Plan that addresses debris removal and disposal during an emergency or disaster. City and County Solid Waste staff are on 24 hours stand-by for debris removal and disposal. Tipping fees for the appropriate waste are waived during the response/recovery phases of the emergency or disaster. In addition, City Solid Waste forces are prepared to receive contaminated petroleum soil and clay from city or county property at the City Landfill and maintain the soil for remediation.

The following sites have been identified as emergency staging areas and will be coordinated with Jeff Batten, Durham City/County Emergency Management Director – 919-560-0660, pager 506-6460, cellular 632-1597 for the processing and management of disaster-related waste:

- The City of Durham Landfill "Borrow Area" within the closed municipal landfill at 1833 Camden Avenue, Durham NC. The point of contact is Nancy Newell at (919) 560-4381.
- The parking lot of the Durham County Stadium at 2700 Stadium Drive, Durham NC. The point of contact is Mike Turner at (919) 560-0431.
- Hansen Aggregate at 1423 Bacon Road, Durham NC. The point of contact is Thomas Smith at (919) 479-0500.
- Falls Lake "borrow area" in Durham County. The point of contact is Thomas Freeman at (919) 846-9332 with the US Army Corp of Engineers at Falls Lake Dam, Raleigh NC.

The availability of these sites is contingent on any current projects that may have begun between the time of identification and time of disaster need.

 The County and City Emergency Operations Plan will be maintained and updated as necessary. Contracts for disposal services will include provisions for assistance in emergency situations.

Report From Tax Administrator on Revaluation

<u>County Manager's Recommendation</u>: The Manager recommended that the Board receive the report and instruct staff as to any additional action that may need to be taken.

Chairman Black gave direction to Tax Administrator Steve Crysel to give another update regarding the status of the revaluations at the Board's August 27, 2001 Regular Session and again at the September Worksession.

<u>Public Hearing on Coordinated Transportation: FY 2001-2002 Rural Operating</u> Assistance Program (ROAP) Grant—Application Approval

The Cooperative Extension Service requested that the Board approve the Rural Operating Assistance Program (ROAP) grant to be submitted to the North Carolina Department of Transportation (NCDOT). The ROAP consolidates the Elderly and Disabled Transportation Assistance Program (EDTAP) with the Work First/Employment Program

into a single application package. EDTAP provides for assistance in the transportation of the elderly and disabled. Work First/Employment Program is intended to provide operating assistance for transitional Work First and general public employment transportation needs for Durham County residents. The application proposes that \$78,292 in governmental revenue be allocated to support transportation for Durham County Elderly and Disabled residents through the Elderly and Disabled Transportation Assistance Program (EDTAP) and \$18,135 to support transportation for Work First Transitional/Employment. These funds **require no local match** while supporting the transportation needs of citizens through County and nonprofit human service agencies. Funding would be used to assist with transportation services from July 1, 2001 through June 30, 2002.

The NCDOT annually allocates funds for EDTAP and Work First. Durham County will receive a total of \$96,427 for FY 2001-2002. Funds shall be used to provide services for the noted agencies:

Council of Senior Citizens Dept. of Social Services (Adult)
Durham Exchange Club Industries Retired and Senior Volunteer Program
Services for the Blind

<u>Resource Person(s)</u>: Cheryl Lloyd, County Cooperative Extension Director, and Johnny Ford, Transportation Access Coordinator

<u>County Manager's Recommendation</u>: Approval of the ROAP application for submittal to NCDOT.

Chairman Black opened the public hearing that was properly advertised.

As no one signed to speak at this public hearing, Chairman Black closed the public hearing and referred the item back to the Commissioners.

Commissioner Heron moved, seconded by Vice-Chairman Reckhow, to approve the ROAP application for submittal to NCDOT.

The motion carried unanimously.

<u>Public Hearing for Zoning Ordinance Text Amendment—Nonconforming Lots</u> (TC116-01)

Staff proposed an amendment to Section 19.5 of the Zoning Ordinance that covers the development of vacant nonconforming residential lots of record. The amendment allows a lot that was lawfully created and met the zoning regulations at the time prior to January 1, 1994 and is a minimum of 50 feet in lot width to be developed by right. The amendment also changes certain language involving required recombinations of adjacent nonconforming lots of record in both Section 19 and the Watershed Ordinance.

Resource Person(s): Dennis Doty, Planner, and Dick Hails, Interim Planning Director

<u>County Manager's Recommendation</u>: The Manager's recommendation was that the Board hold the Public Hearing and approve the amendment, if appropriate, based upon public comment.

Chairman Black opened the public hearing that was properly advertised.

Mr. Bill Ripley, 1912 Hwy. 54, expressed that this is a needed ordinance change. He felt that specific nuances in the ordinance must be worked out and asked the Commissioners to delay action for two weeks to consider modifications.

Chairman Black asked that the County Attorney review this ordinance while taking under consideration the three issues introduced by Mr. Ripley.

As no one else asked to speak at the public hearing, Chairman Black closed the hearing and referred the item to the Commissioners for consideration.

Vice-Chairman Reckhow moved, seconded by Commissioner Cousin, to defer action on this item and staff was directed to revisit the comments and issues that were raised.

The motion carried unanimously.

<u>Public Hearing for Zoning Ordinance Text Amendment—to Reduce the Separation</u> <u>Requirements Between Kennels and Single Family Residential Uses in Non-Residential Zoning Districts</u>

Staff recommended an amendment to Section 7 Supplementary Requirements to remove the existing 300-foot separation between kennels and single-family uses in non-residential zoning districts and replace the separation with a solid fence between the uses.

Resource Person(s): Dick Hails, Interim Planning Director

<u>County Manager's Recommendation</u>: The Manager's recommendation was that the Board hold the public hearing, receive public comment, and approve the amendment to the ordinance.

Chairman Black opened the public hearing that was properly advertised.

Two citizens had signed to speak at this hearing; however, they left the meeting prior to discussion of this item.

As no one else asked to speak at the public hearing, Chairman Black closed the hearing and referred the item to the Commissioners for consideration.

<u>Public Hearing for Zoning Ordinance Text Amendment-Requirements to</u> Discourage the Use of "Spite Strips" in Rezoning Requests

Staff proposed an amendment to Section 15.2.1 of the Zoning Ordinance that establishes the application process for rezonings to add provisions to be used to discourage the use of "spite strips" as a way to bypass the filing of protest petitions in rezoning cases.

Resource Person(s): Dick Hails, Interim Planning Director

<u>County Manager's Recommendation</u>: The Manager's recommendation was that the Board hold the public hearing, receive public comment, and approve the text amendment.

County Manager Ruffin changed his recommendation subsequent to information made available to him in discussions with the County Attorney today. His new recommendation was that the Board hold the public hearing, receive public comment, and then direct the staff accordingly based on discussions that will ensue.

Chairman Black opened the public hearing that was properly advertised.

Steve Bocckino, 7340 Abron Drive, Durham 27713, spoke in favor of this amendment.

<u>Bill Ripley</u>, 1912 Hwy. 54, Durham, said the amendment restricts developers' flexibility and will have negative consequences.

<u>Larry D. Hall</u>, 315 E. Chapel Hill Street, felt that certain issues should be considered prior to approval, including the impact on future infield development and affordable housing.

After a lengthy discussion, the Commissioners directed staff to make changes to this zoning ordinance text amendment.

Commissioner Heron moved, seconded by Vice-Chairman Reckhow, to continue the public hearing for two weeks and for staff to consider the comments regarding this item and bring it back before the Board at the August 27, 2001 meeting.

Public Hearing—AB-TAK III, Applicant (Rezoning Case P01-06)

AB-TAK III presented to the Board of County Commissioners a request to rezone 3.63 acres located on the east side of Stallings Road, north of Patterson Road PIN #0861-03-01-7899; 0861-03-01-7695 (TM 667, Block 1, Lot 3A, 24) Request: RD to R-15, F/J-B. The proposal was in general conformance with the draft small area plan and 2020 Plan. Staff recommended approval. The Zoning Committee of the Durham Planning Commission conducted a public hearing on June 12, 2001 and voted 5-2 to recommend approval.

The public hearing for this request was advertised on July 27 and August 3, 2001 in the Durham Herald-Sun.
