Welcome

Chairman Black welcomed everyone to the meeting.

Chairman Black requested that Daniel C. Hudgins, Director of Social Services, give his report.

Commissioner Heron cited complaints about customer service and the services that the Social Services Department is providing our citizens.

Dan Hudgins responded to Commissioner Heron's comments and remarks.

Vice-Chairman Reckhow stated she had received complaints about the Child Support Department. She asked Mr. Hudgins to provide the Commissioners additional data relative to how we compare to other counties in caseload in the child support area. Clients are not getting straight answers and there is a lack of accountability.

The Commissioners made comments and asked questions about the Social Services Department. Mr. Hudgins responded to the Commissioners' questions and comments.

Commissioner Bowser stated he has received complaints about the Social Services Department.

County Manager David F. Thompson talked about the Customer Service Committee that has been established by the administration and the work and recommendations made by the committee. Follow-up activities were also discussed.
