## **Opening of Regular Session**

Chairman Black called the Regular Session to order with the Pledge of Allegiance.

### **Agenda Adjustments**

County Manager David F. Thompson asked that approval of the Register of Deeds' automation project be added to the consent agenda. As a part of the approval, a budget ordinance amendment is needed in the amount not to exceed \$1,232,244 from the pay-as-you-go plan to the Register of Deeds' budget. The Commissioners must authorize that the County Manager enter into a contract with Hart Information Services in an amount not-to-exceed \$532,244.

Commissioner Heron asked for a discussion on delinquent property taxes.

Commissioner Bowser asked permission to make remarks about the staffing of companies that move into Durham County.

#### **Minutes**

Vice-Chairman Reckhow requested that a list of directives be provided the Commissioners each month.

County Manager Thompson responded that a detailed list is updated weekly. A copy of the directives list can be sent to the Commissioners each Wednesday.

# <u>Declaration of Surplus Property—0.13-Acre of Unused Hillandale Elementary School Land</u>

The Durham Public Schools Board of Education has declared surplus real property comprising a 0.13-acre of unused Hillandale Elementary School land located at the rear of the property adjacent to Guess Road.

The North Carolina Department of Transportation has requested this land for a right-of-way to accommodate the planned improvements to Guess Road. An offer of \$8,125 has been received from NCDOT to purchase the 0.13-acre of unused land.

N.C.G.S. 115C-518 mandates that the Board of County Commissioners has the right of first refusal to acquire this property. The Board of Education will not entertain any offer until the Board of County Commissioners has considered its option and has taken formal action.

The Board of Education hereby offers for sale to the Board of County Commissioners the above referenced property.

Michael Mulheirn, Assistant Superintendent for Operations Services, presented the Commissioners an overview of the request.

Vice-Chairman Reckhow moved, seconded by Commissioner Heron, to decline the offer to purchase the surplus property.

The motion carried unanimously.

## <u>Declaration of Surplus Property—9,339-Square-Feet of Club Boulevard Elementary</u> School Land

The Durham Public Schools Board of Education has declared surplus real property comprising 9,339-square-feet of Club Boulevard Elementary School land located in the southwest corner of the play field adjacent to Interstate 85 and Club Boulevard.

The North Carolina Department of Transportation has requested this land for a right-of-way to accommodate the planned improvements to Interstate 85. An offer of \$7,000 has been received from NCDOT to purchase the 9,339-square-feet of land.

N.C.G.S. 115C-518 mandates that the Board of County Commissioners has the right of first refusal to acquire this property. The Board of Education will not entertain any offer until the Board of County Commissioners has considered its option and has taken formal action.

The Board of Education hereby offers for sale to the Board of County Commissioners the above referenced real property.

Michael Mulheirn, Assistant Superintendent for Operations Services, presented the Commissioners an overview of the request.

Commissioner Bowser moved, seconded by Vice-Chairman Reckhow, to decline the offer to purchase the surplus property.

The motion carried unanimously.

## Advertisement of Delinquent Taxes

Commissioner Heron asked what could be done to get people to pay their property taxes.

County Manager David F. Thompson said the foreclosure cycle has been reduced from four years to one year. We will go after the people who do not pay the taxes because it is an issue of tax equity. The records show that after one year we will collect real and business property taxes at a 99 percent collection rate. It is not much we can do that is

not already being done as far as being aggressive in collection because it is governed by state law and the Machinery Act. Taxes will be collected in a one- to two-year period by some method.

Charles Clark, Tax Administrator, said the big problem is collecting taxes on motor vehicles. Stronger legislation is needed to collect motor vehicle taxes.

Vice-Chairman Reckhow stated that we should re-institute the practice of checking businesses to see that all property taxes are paid before the County makes purchases from them.

County Manager Thompson said we could check the vendors to see if their taxes are paid before we make a purchase.

## Authorization for Construction on New Hope Creek Nature Trail

#### Background

Over the past several years, the County has acquired over 220 acres of land using 1986 County Park and Recreation Bonds (over 170 acres of that is in the New Hope Creek Corridor). Many citizen groups have worked over the past year-and-a-half to construct a two-mile nature trail along New Hope Creek in southwestern Durham County, just south of US 15-501. This is the first nature trail in the New Hope Creek Corridor and the first on County-owned property acquired with the 1986 bonds.

#### Analysis

Much of the property in the New Hope Corridor is in the sensitive flood plain area. The staff laid out the trail route for a minimal impact on the trail site. For the trail to be fully usable year-round, the following professional construction elements are necessary: bridges, boardwalk sections, and culverts. The cost of professional engineering and construction is estimated at \$75,000. In 1998, the County was awarded a grant of \$30,000 by the National Recreational Trails Fund program for this construction to complete the trail; the County must match the money. Another \$8,000 was pledged to the County for work on this trail by the New Hope Audubon Society. The County would spend \$40,000 from 1986 bond funds for the work.

#### Staff recommendation

The staff recommends (1) a standard bid process to award the contract for design and construction of these items; and (2) the use of \$40,000 from the 1986 bond funds as matching money for the federal grant.

Beth Timson, Senior Planner, Durham City-County Planning Department, presented the Commissioners an overview of the proposal relative to the New Hope Creek Nature Trail.

Commissioner Heron moved, seconded by Vice-Chairman Reckhow, to approve the staff recommendation.

The motion carried unanimously.

## **Review Ambulance Franchise Renewal and Modification**

In 1982, Durham County adopted a local Ambulance Service Franchise Ordinance in order to monitor the provision of ambulance service in the County. The ordinance requires that all approved operators apply for a franchise renewal every 4 years.

Currently, six franchised operators are due for renewals, and one has requested a modification of their existing franchise to expand its business within Durham County.

Lebanon, Bahama, Bethesda, Redwood, and Parkwood Volunteer Fire Departments, and Duke Life Care have submitted renewal requests.

In addition, Johnston Ambulance Service has requested that its franchise be modified to allow expansion of service at the Basic Life Support and Convalescent levels to be able to respond to requests from Duke Hospital and others to provide this service. The current franchise limits Johnston Ambulance Service to Basic Life Support service under contract for the VA Medical Center.

The Durham County EMS Director and the Durham County EMS Council, at their meeting on March 18, 1999, reviewed all requests and recommended them for approval.

Mickey Tezai, Director, Emergency Medical Services, presented the Commissioners an overview of the ambulance franchise renewal and modification.

Commissioner Heron moved, seconded by Vice-Chairman Reckhow, to approve the ambulance franchise renewal for Lebanon, Bahama, Bethesda, Redwood, and Parkwood Volunteer Fire Departments and Duke Life Care.

The motion carried unanimously.

Commissioner Bowser moved, seconded by Vice-Chairman Reckhow, to approve the request of Johnston Ambulance Service to modify its franchise to allow expansion of service at the Basic Life Support and Convalescent levels only, anywhere in Durham County. Johnston will attend regular meetings of the audit and review subcommittee of the Mobile Intensive Care Committee to report on its activities. Also, it will provide monthly statistical reports to the EMS Director. Johnston will have a 30-minute response anywhere in Durham County.

The motion carried unanimously.

Johnston Ambulance Service was in agreement with the conditions in the motion.

## **Four-Year Terms**

As per the County Commission's direction, a public hearing has been scheduled for this meeting to receive citizen comments on four-year terms for the County Commissioners. Included in the agenda package are a copy of the proposed legislation and a summary of the NC County Election Methods—1998, including a listing of terms of office. Staff has also obtained information from NACo on national methods.

Also, the County Commissioners requested that the Public Information Office be aggressive in soliciting participation and input. To this end, the following items are also included in the agenda package:

- Notice of Public Hearing
- WEB Page designed to solicit public input and notice of hearing
- A script used for telephone conversations with citizens that attended our Community Forums. It asks for input and also has a notice portion (utilized by Cooperative Extension on our behalf).

Chairman Black opened the public hearing that was properly advertised.

Mr. Scott Edwards, 2323 Trailwood Drive, Durham, Chief Administrative Officer of Central Carolina Bank, speaking on behalf of the Chamber's position, stated Commissioners' terms should be extended to four years. Future Commissioners should be given the opportunity for continuity to handle the complex problems.

Mr. Patrick Byker, 2614 Stuart Drive, spoke on behalf of the Greater Durham Chamber of Commerce. He said the Chamber's Board, on two occasions, unanimously supported the Durham County Board of Commissioners having four-year terms.

Mr. Jack Steer, 2416 Dawn Trail, representing the Friends of Durham, said the organization has not taken a position to favor or disfavor this issue primarily because we do not see the relevance of term length on the current and important issues facing the County. All of the Commissioners have endorsed, to one degree or another, the concept of City/County merger, and we feel that diverting attention and effort away from it could cloud this important issue. The term length subject could even present delays and obstructions to merger. Our conclusion on the subject is that the current timing and implementation methods being considered on term length are inappropriate. We recommend holding a referendum in the Year 2000 election on the subject of term length.

Mr. Ralph McKinney, 500 Fairfield Road, stated he does not favor merger or four-year terms.

Ms. Pat Bocckino, 7340 Abron Drive, 27713, stated the time has come for four-year terms to give the Commissioners a chance to achieve their goals before having to run again. A referendum on this issue should be held in the Year 2000.

Ms. Julie Linehan, 3437 Dixon Road, 27707, favored four-year terms. A referendum should be held in 1999 on the four-year term proposal.

Ms. Carol Lane, 6517 Bakersfield Road, Raleigh, represented Common Cause/NC members in Durham County. We work for open, honest, and accountable government. We strongly urge you to do this through the referendum route. This referendum should be done at the County elections, not the City elections.

As no one else asked to speak at the public hearing, Chairman Black closed the hearing and referred the item to the Commissioners for consideration.

The Clerk's Office and Public Information Office received three letters regarding this issue.

Citizens who participated in the Community Conversations were polled to get their opinion on the four-year terms. The survey results were as follows:

39 contacts made

25 (64%) preferred four-year terms

4 (10%) preferred a countywide referendum and were undecided

5 (13%) preferred two-year terms

5 (13%) had no opinion

3 of the 25 suggested staggered terms

The Board of County Commissioners had a general discussion about four-year terms after the public hearing. The Commissioners expressed their opinions on the subject during the discussion.

Chairman Black said the Commissioners concur that there will be a referendum and we are in agreement to send a letter to Representative J. M. Michaux Jr. asking him not to submit the bill.

Vice-Chairman Reckhow moved, seconded by Commissioner Heron, that if we make any changes in the terms of the Board of County Commissioners, it will be done by referendum.

The motion carried with the following vote:

Ayes: Black, Heron, and Reckhow

Noes: Bell and Bowser

Commissioner Bowser moved, seconded by Commissioner Bell, to send a letter to Representative Michaux stating that we would request he not submit the General Statute on extending the terms to four years for county commissioners.

The motion carried unanimously.

## **Recruitment of Employees**

Commissioner Bowser raised the question about businesses in Durham County having a difficult time recruiting employees.

Commissioner Bowser suggested that job openings be posted at Durham Technical Community College and City and County Government Buildings since a rumor is going around that we don't have people to take these jobs. There are people in the job market. People should contact Mr. Ted Conner at the Durham Chamber of Commerce.

Mr. Thomas White, Chief Executive Officer, Chamber of Commerce, spoke about the labor market in Durham and where the jobs are posted.

The Commissioners had a general discussion about the job market and the posting of jobs.

Commissioner Bowser said if a missing link exists between the employers and employees, the employer should not say employees are hard to find. That is misleading.
