Opening of Regular Session

Chairman Reckhow called the meeting to order with the Pledge of Allegiance.

Announcement

Commissioner Heron announced that she and Chairman Reckhow attended the musical performance, "Grease," at Hillside High School on Friday night, November 7. She commented that the production was "fantastic", the actors "professional", and the orchestra "superb". She encouraged all citizens to attend future performances.

Chairman Reckhow echoed the comments of Commissioner Heron, commending Mr. Wendall Tabb, Hillside High School Theatre Director, for another exceptional production.

Minutes

Recognition for "Learning 4-All" Bond Committee

MaryAnn E. Black, Director of Community Affairs, Duke University Health System, and former Durham County Commission Chairman, and Stephens Toler, Vice President of Community Relations, Verizon, co-chaired the committee responsible for the successful marketing and passage of Durham County's \$124 million bond referendum on November 4, 2003.

<u>COUNTY MANAGER'S RECOMMENDATION</u>: The Manager recommended that the Commissioners congratulate all members of the "Learning 4-All" Committee for a successful bond campaign.

Chairman Reckhow presented the resolutions to Mr. Toler and Ms. Black.

Ms. Black presented to the Board copies of a thank-you letter that she and Mr. Toler had written to the Commissioners, Board of Education, County Manager, and Durham Public Schools Superintendent.

Ms. Black then read the letter into the record:

"Thank you for giving us the opportunity to serve as co-chairs for the 2003, \$124 million *LEARNING 4-All Bond Campaign*. The Commissioners, the School Board, and both administrations created a well-planned educational bond. It enabled us to present the bond package to the community, and it helped voters understand the importance of the bond. We were privileged to

speak to many civic organizations, education and political groups about the bond package, and we successfully convinced them to endorse it.

During these sessions, groups gave us many kind suggestions to make the next bond stronger. One of the most frequently asked question was, "How will the bond impact property taxes for homeowners"? Perhaps you could create a chart that shows, on an upward scale starting at \$80,000, the best and worse case scenarios for homeowners' property taxes. The second most frequently asked question was, "How much did the previous bond increase property tax"? A chart that shows the impact of the last three bonds would help address this issue.

There needs to be stronger procedures for public input before the Capital Improvement Plan is developed. We suggest that the School Board and the County Commissioners have coffee time with the community leaders, stake holders, groups of citizens, and other interested parties to receive input on the bond item before the final preparation of the package and to help citizens understand how the package is being designed, while allowing opportunity for discussion or changes, if warranted.

The Bond Campaign Steering Committee did not have enough Parent Teachers Association (PTA) members. In the future, PTA volunteers should be named as a part of the committee. There should also be a person to coordinate the volunteer activities for the telephone bank, to remove signs, etc.

The following are issues that need to be addressed now that the bond has passed.

- 1. The School Board needs to ensure that site based committees receive community input on all building designs (particularly Fayetteville Street and C.C. Spaulding). This is consistent with the current process and with the goals of the schools serving as community hubs.
- 2. The School Board needs to commit to building a new band suite at Hillside High School and to identify the appropriate resources to accomplish this.
- 3. To provide accountability, quarterly reports should be made available for all bond projects. The reports could be posted on various web sites, in libraries, or given to citizens at their request.
- 4. The School Board needs to address the issue of whether small schools have access to similar resources as large schools.

- 5. Fayetteville Street and C.C. Spaulding should have health rooms and the resource rooms should be located on the same floor as the primary classrooms, if possible.
- 6. The School Board needs to explore whether the City will allow the expansion of Fayetteville Street School into the adjacent park.
- 7. The School Board needs to continue to work diligently to identify resources for the Vocational/Technical School.
- 8. When an institution receives funds from a bond referendum, and not all the funds are spent for the specified project, management must account to the public for any unused funds before seeking additional funds in the next bond.

We thank all the members of the steering committee for their hard work. We thank Dr. John Lucas for being our honorary chairman. We thank the staff of the County, Durham Public Schools, Durham Technical Community College, the Durham Public Libraries, and the staff at the Museum of Life & Science for their help with the bond passage. Marilynn Walls, President of The Creative Mark, and Deborah Craig-Ray are to be commended especially for the many long hours they put into this campaign.

Finally, we thank the people of Durham County for voting "Yes" to *Learning* 4-All. They will help us upgrade old facilities, build new structures, and improve schools throughout our community. We are indeed a great community of people, who value our public facilities and, most importantly, value *Learning* 4-All."

Ms. Black requested that the Commissioners hold discussions with the Board of Education regarding the contents of the letter, adding that she and Mr. Toler would be available to help in the future, if needed.

Chairman Reckhow responded that several of these recommendations would be placed on an upcoming County Commission/Durham Public Schools Board of Education meeting agenda.

Resolution Supporting Western North Carolina Passenger Rail Service

Representatives of the Western Carolina Rail Corridor Committee contacted the Chairman of the Board about joining a North Carolina Statewide Passenger Rail Initiative, which seeks to restore passenger rail service to Western North Carolina. Support is being sought from across the state. All approved resolutions will eventually be presented to state legislators.

<u>COUNTY MANAGER'S RECOMMENDATION</u>: The Manager recommended that the Board approve the resolution and direct that a signed copy be returned to Judith Calvert Ray, Chair, WNC Rail Corridor Committee.

The resolution follows:

RESOLUTION IN SUPPORT OF A STATEWIDE INITIATIVE FOR LEGISLATIVE AND FUNDING SUPPORT FOR ENHANCED AND IMPROVED PASSENGER RAIL SERVICE FOR THE STATE OF NORTH CAROLINA

WHEREAS, a passenger rail service is an integral part of a comprehensive transportation system for the state of North Carolina; and

WHEREAS, economic development, tourism and job creation will benefit through the enhancement of a passenger rail system that serves the citizens of North Carolina and visitors to our state; and

WHEREAS, we applaud the State of North Carolina for development of comprehensive intercity rail services in urban jurisdictions throughout the state; and

WHEREAS, there is a vital need to provide a balanced transportation system both statewide and nationwide as demonstrated in the aftermath of the September 11, 2001 tragedies; and

WHEREAS, an increase in state funding for passenger rail service in North Carolina is necessary to support development of intercity rail services that can connect our small urban and rural areas of the state with the urbanized centers of our state; and

WHEREAS, support by local and state elected officials is essential for the future of alternative transportation in North Carolina; and

WHEREAS, support and utilization of transportation improvements by business and commercial interests is essential for the successful deployment of alternative transportation modes in North Carolina; and

WHEREAS, this resolution is a vehicle to express the unified support of communities and chambers of commerce throughout North Carolina for increased statewide funding of passenger rail service; and

WHEREAS, rail linkages between communities and regions within North Carolina establish and strengthen social, historical, commercial and cultural bonds; and

WHEREAS, the average return on investment for the surrounding community for station revitalizations throughout North Carolina is more than one dollar for every dollar invested; and

WHEREAS, the associated improvements to rail facilities will increase the efficiency and safety of rail service, help attract new freight traffic and provide environmental benefits by reducing the impact of truck traffic on North Carolina's highways and by reducing harmful emissions; and

WHEREAS, an integrated passenger rail system will enhance accessibility and reliability for key military locations and ports:

NOW, THEREFORE, BE IT RESOLVED that we, the members of the Durham County Board of Commissioners, through the adoption of this resolution, fully support the creation of a comprehensive passenger rail system to serve the State of North Carolina, with its ultimate objective to further economic opportunity, help preserve the

environment, improve the quality of life and enhance public health, safety and welfare for all citizens, communities and regions.

Section 1. At a special bond referendum held in the County of Durham on November 4, 2003, 128,176 voters were registered and qualified to vote.

At said referendum 23,766 votes were cast for the order adopted on July 28, 2003, authorizing not exceeding \$105,315,000 School Bonds of the County of Durham, North Carolina, for the purpose of providing funds, with any other available funds, for erecting additional school buildings and other school plant facilities, remodeling, enlarging and reconstructing existing school buildings and other school plant facilities and acquiring any necessary land, furnishings and equipment therefor, in order to provide additional school facilities in said County to maintain the school term as required by Section 2 of Article IX of the Constitution, and authorizing the levy of taxes in an amount sufficient to pay the principal of and the interest on said bonds, and 6,377 votes were cast against said order, and a majority of the qualified voters of said County who voted thereon at said referendum voted in favor of said order.

At said referendum 23,861 votes were cast for the order adopted on July 28, 2003, authorizing not exceeding \$8,345,000 Community College Bonds of the County of Durham, North Carolina, for the purpose of providing funds, with any other available funds, for expanding and improving the facilities for Durham Technical Community College at its main campus in the City of Durham, including the construction of an additional building and additional parking facilities and sidewalks, the expansion and improvement of an existing building, the improvement of other facilities and the acquisition of necessary furnishings and equipment therefor, and authorizing the levy of taxes in an amount sufficient to pay the principal of and the interest on said bonds, and 6,946 votes were cast against said order, and a majority of the qualified voters of said County who voted thereon at said referendum voted in favor of said order.

At said referendum 22,083 votes were cast for the order adopted on July 28, 2003, authorizing not exceeding \$5,280,000 Museum Bonds of the County of Durham, North Carolina, for the purpose of providing funds, with any other available funds, for enlarging and improving exhibits, parking facilities, visitor facilities, offices and maintenance facilities at the North Carolina Museum of Life and Science and acquiring any necessary furnishings and equipment therefor, and authorizing the levy of taxes in an amount sufficient to pay the principal of and the interest on said bonds, and 8,435 votes were cast against said order, and a majority of the qualified voters of said County who voted thereon at said referendum voted in favor of said order.

At said referendum 24,144 votes were cast for the order adopted on July 28, 2003, authorizing not exceeding \$4,725,000 Library Facilities Bonds of the County of Durham, North Carolina, for the purpose of providing funds, with any other available funds, for providing additional library facilities of said County, including the construction of a branch library in the southern area of said County and the acquisition of necessary furnishings and equipment therefor, and authorizing the levy of taxes in an amount sufficient to pay the principal of and the interest on said bonds, and 6,558 votes were cast against said order, and a majority of the qualified voters of said County who voted thereon at said referendum voted in favor of said order.

Transportation Improvement Program (TIP) for FY 2006-2012

The Transportation Improvement Program (TIP) determines how state and federal transportation funds will be spent throughout Durham County and the State of North Carolina in upcoming years. The biannual TIP preparation begins with a process of setting of priorities by local jurisdictions. Each jurisdiction gives a priority recommendation for transportation projects which have not been funded or which are partially funded. In the past, the Board of County Commissioners has elected to hold a public hearing on the TIP. It was suggested that a public hearing be scheduled for November 24, 2003. The proposed priority list will be advertised prior to the hearing. Following the public hearing, the Board will be requested to adopt the TIP priorities.

<u>COUNTY MANAGER'S RECOMMENDATION</u>: The County Manager's recommendation was that the Board receive the presentation and schedule a public hearing for November 24, 2003.

Commissioner Heron inquired about the construction on Cornwallis Road interfering with bikeways.

Mr. Ahrendson responded that he is aware of bikeway interruption at the intersection of the Northeast Creek Parkway and Cornwallis Road; new parkway construction has narrowed lanes in that area. Mr. Ahrendson stated that his department is working with NCDOT and will get the problem corrected in one of three ways: (1) the NC 55 TIP project; (2) enhancement project scheduled to provide bicycle improvements along Cornwallis Road from NC 55 to Miami Boulevard; or (3) a North Carolina "Moving Ahead" project to widen and resurface Cornwallis Road from Fayetteville Road to Miami Boulevard (overlaps the enhancement project).

Commissioner Heron recommended that the South Miami Boulevard project be accelerated, especially since a relatively small amount of funding is involved.

Mr. Ahrendson suggested that her recommendation be presented to the Transportation Advisory Committee; he would present it to NCDOT, as well.

Vice-Chairman Bowser discouraged NCDOT's plans for rerouting Hillandale Road traffic to Guess Road and vice versa during I-85 ramp closure. He suggested that Hillandale Road be increased to four lanes immediately (instead of the temporary appendage of a third lane) with additional stoplights so citizens can frequent businesses without the threat of a traffic accident.

Mr. Ahrendson stated that he would relay this suggestion to NCDOT.

Vice-Chairman Bowser asked Mr. Ahrendson to contact the Board with NCDOT's response so other actions can be taken by the Commissioners, if necessary.

Commissioner Jacobs moved, seconded by Commissioner Heron, to set a public hearing for the November 24, 2003 Regular Session for the priority list as presented.

The motion carried unanimously.

Chairman Reckhow stated that she was pleased with the well-balanced list between road transit and bicycle improvements.

Hearing on Request for Refund of Excise Tax

The County has received a request to refund tax stamps paid on three correction deeds recorded in Durham County. On October 3, 2003, three deeds were recorded to correct the Declaration of Condo and legal descriptions for several condominiums. After hearing the sworn testimony, the Board may refund the amount of the taxes (\$531.00) retained by the County. The remainder of the taxes must be refunded by the State; the applicant is responsible for making this request.

The applicant was duly notified of the hearing on the requested refund.

<u>COUNTY MANAGER'S RECOMMENDATION</u>: After hearing the testimony of the applicant, the Board was requested to approve the order for the refund, if appropriate.

Attorney Darin P. Meece was sworn in by Clerk to the Board Garry Umstead.

Attorney Meece gave sworn testimony explaining that on October 3, 2003, his office recorded three correction deeds, correcting legal descriptions in deeds filed several months earlier, on which excise tax was paid. The Register of Deeds accidentally collected a second set of excise tax. Accordingly, he was due a refund of \$1,062.00 pursuant to N.C.G.S. § 105-228.37.

Vice-Chairman Bowser moved, seconded by Commissioner Jacobs, to approve the order for the refund.

THIS matter coming on to be heard and being heard before the Board of Commissioners for the County of Durham at its November 10, 2003 meeting upon petition for a refund of excise taxes paid to the Register of Deeds of Durham County. Based on the testimony presented at the hearing and on the evidence presented, the Board makes the following FINDINGS OF FACT:

- 1. On or about October 3, 2003, the Petitioner caused three correction deeds to be recorded in the Register of Deeds Office on which excise taxes were paid in the amount of \$1,062.00.
- 2. The excise tax was paid in error, as the transaction was not a conveyance of an interest in property that would be subject to excise stamps under G.S. § 105-228.28.
- 3. The amount of the excise taxes which were retained by the County as its share of the excise taxes was in the amount of \$531.00.
- 4. Prior to making the refund requested, the Petitioners are required to record an instrument indicating the deeds are not subject to excise stamps.

Based on the foregoing findings of fact, the Board makes the following CONCLUSIONS OF LAW:

- 1. The Board of Commissioners has jurisdiction over this matter.
- 2. The Petitioner is entitled pursuant to G.S. § 105-228.37 to a refund of the County=s share of the excise stamp taxes in the amount of \$531.00.

IT IS THEREFORE ORDERED:

- 1. The Finance Officer for the County of Durham shall pay to the Petitioner the sum of \$531.00 as a refund of the excise stamp taxes erroneously paid.
- 2. The Clerk to the Board of Commissioners shall send a copy of this Order to the Secretary of Revenue for the State of North Carolina.
