Call to Order

Mr. Ott gave a PowerPoint presentation entitled, "Applying the Results-Based Accountability Framework—Improving Performance Within County Departments," which focused on the following questions of performance measures and their application to departments and programs:

- 2. How can we measure if our customers are better off? (performance measures about client results e.g. percent of children with good literacy skills)
- 3. How can we measure if we are delivering service well? (e.g. client staff ratio, unit cost, turnover rate, etc.)
- 4. **How are we doing** on the most important of these measures? Where have we been; where are we headed? (baselines and the story behind the baselines)
- 5. Who are **the partners** who have a potential role to play in doing better?
- 6. **What works**, what could work to do better than baseline? (best practices, best hunches, including partners' contributions)
- 7. What do we propose to do?
