Commissioner Reckhow publicized a recent newspaper insert that highlighted programming at various Durham County Library branches for the months of March, April and May 2014. She invited citizens to obtain further information about the programs by visiting any library location in-person or via the Durham County Library website. Commissioner Reckhow emphasized that there were programs for people of all ages and interests.

Chairman Page praised the Durham County Library for the good work being done. He stated that the library was providing many wonderful opportunities for citizens. Chairman Page commented on a Herald-Sun newspaper article that recognized Women's History Month. He continued saying that the article highlighted women in leadership, including Vice-Chair Howerton and Commissioners Jacobs and Reckhow. Chairman Page saluted the aforementioned Commissioners and thanked them for their leadership on the Board of County Commissioners.

Mr. Lowell Siler, County Attorney, announced that Ms. Carol Hammett, Deputy County Attorney had resigned from her position with Durham County Government. Attorney Siler stated that Ms. Hammett would be working as the General Counsel for Alliance Behavioral Healthcare. He continued saying that Ms. Hammett produced high-quality work on behalf of the County in many different areas. In closing, Attorney Siler thanked her for doing such a great job during her tenure.

The Board thanked Ms. Hammett for her professionalism and service to Durham County; and wished her the best in her new position.

Ms. Hammett provided brief remarks thanking the Board and County Attorney Siler for the recognition. Ms. Hammett acknowledged the staff of the County Attorney's Office and other County staff who helped to create a proficient and personable workplace.

# **Proclamation – Professional Social Work Month**

Commissioner Page read the following proclamation into record:

WHEREAS, social workers stand up for others to make sure everyone has access to the same basic rights, protections, and opportunities; and

WHEREAS, social workers help people help themselves, whenever and wherever they need it most; and

WHEREAS, social workers have been the driving force behind important social movements in the United States and abroad; and

WHEREAS, social workers in the Durham County Department of Social Services invest in people so that they can contribute more to the economic and social wellbeing of our community; and

WHEREAS, the National Association of Social Work's 2014 theme is *All People Matter* and social workers in the Durham County Department of Social Services respect that all people matter by assuring families' basic economic needs are met; providing access to health care and nutrition; helping people find jobs and developing strong work habits and a career path; keeping children and families safe; and helping children to be ready for and succeed in school;

Mr. Michael Becketts, Director of Social Services (DSS); Ms. Jovetta Whitfield, Assistant Director of Family Safety and Permanency Services; Ms. Rhonda Stevens, Assistant Director of Family Economic Independence and Ms. Janice Williams, Adoption Supervisor were present to accept the proclamation.

Mr. Becketts thanked the Board for recognizing March 2014 as Professional Social Work Month. He stated that social workers performed their jobs to ensure that individuals were treated with dignity and respect. He continued saying that there were 175 social workers in DSS who performed countless duties and went above and beyond what was expected. Mr. Becketts closed saying that there was an overarching theme within the department that "all people matter."

Chairman Page extended thanks to staff of the Department of Social Services for the work that they do and their commitment to the citizens of Durham County.

Referencing consent agenda item "a," Commissioner Reckhow stated that the reallocated child care revenue was indicative of a highly performing DSS. She continued saying that in order to receive the funds in question, the DSS must show good money management by efficiently using funds with no overages. Commissioner Reckhow praised the DSS for obtaining this level of funding and providing Durham County citizens with access to high-quality child care services.

Commissioner Jacobs thanked DSS staff for services that they provide. She stated that she enjoyed working with the DSS Board and gaining first-hand knowledge of how the department works together. Commissioner Jacobs commented that the DSS were "front-line" personnel in the community who ensured that basic needs were met across diverse populations. She also noted that the Board recently met with the DSS Board to discuss a potential Medicaid services crisis, which brought to light other recent difficulties regarding NCFAST and meeting service needs. Commissioner Jacobs expressed her desire for a formal celebration in recognition of Professional Social Work Month.

Vice-Chair Howerton thanked DSS staff. She stated that the work that they perform positively affected the hearts and minds of Durham County residents.

Vice-Chair Howerton moved, seconded by Commissioner Reckhow, to approve the following consent agenda items (7a, c, d, e, f and g):

- a. \*Approve Budget Ordinance No. 14BCC000040 recognizing reallocated child care revenue in the amount of \$771,869;
- c. Adopt a resolution requesting the North Carolina Department of Transportation (NCDOT) accept Keeneland Court into the Secondary Road System for state maintenance. Keeneland Court is part of the Keeneland Manor subdivision and intersects with Stagecoach Road;

- d. Adopt a resolution requesting the North Carolina Department of Transportation accept Winner's Circle into the Secondary Road System for state maintenance. Winner's Circle is a part of the Keeneland Manor subdivision and intersects with Keeneland Court;
- e. Adopt the Resolution authorizing the Research Triangle Regional Public Transportation Authority to levy an additional three dollar (\$3.00) vehicle registration tax on motor vehicles registered in the Special Tax District;
- f. Approve an amendment to the legal services contract with Womble Carlyle Sandridge & Rice, LLP by an amount not to exceed \$31,000 and authorize the County Attorney to execute the amendment;
- g. Approve an amendment to the legal services contract with Navigant Consulting, Inc. by an amount not to exceed \$6,000 and authorize the County Attorney to execute the amendment.

The Board of County Commissioners was requested to hold an Advance Public Comment session to receive public comments for the FY 2014-2015 Budget. Chairman Page stated that as County staff began the preparation of the fiscal year 2014-2015 budget, public input was being solicited on issues that may need to be addressed during the budget process. He also encouraged citizens to email their comments to commissioners@dconc.gov.

Mr. Lee Worsley, Interim County Manager, introduced Mr. Keith Lane, Interim Budget and Management Services Director.

Mr. Stephen Hopkins, spoke on behalf of northeast central Durham. He spoke on various issues in that area of Durham including: employment, crime, business opportunities and a lack of affordable housing. He submitted his comments for the record.

Mr. John Martin, Inter-Neighborhood Council, spoke on adequate funding for the City-County Planning Department. Mr. Martin cited difficulty obtaining assistance from the Planning Department on a number of different matters due to staffing constraints. He submitted his comments for the record.

Mr. Vince Hammond, spoke on adequate funding for the City-County Planning Department. Mr. Hammond commented on staffing concerns regarding the Planning Department, which impacted revisions to the current cell phone tower ordinance. He submitted his comments for the record.

Ms. Donna Rudolph, Eagle's Point Homeowner's Association, spoke on adequate funding for the City-County Planning Department. Ms. Rudolph commented on staffing concerns regarding the Planning Department, which impacted revisions to the current cell phone tower ordinance. She submitted her comments for the record.

# **Items Pulled From Consent Agenda**

# Consent Agenda Item No. b

b. Approve the Resolution Authorizing an Electronic Public Auction Sale and authorize the County Manager or designee to follow the surplus disposal procedures for proper disposal and removal of accumulated surplus vehicles.

Commissioner Foster stated that he pulled the item to question for the record if the County did its due diligence to ensure the surplus vehicles in question were unserviceable/unusable by other departments prior to their disposal/removal. Commissioner Foster expressed that the County should strive for cost efficiency and reuse surplus vehicles in other County service areas.

Chairman Page questioned where the County's surplus vehicles go once they receive that designation.

Ms. Jacqueline Boyce, Purchasing Division Manager, stated that surplus vehicles were being stored at the warehouse on Hillsborough Road, but occasionally they were stored on-site by individual departments. Chairman Page recommended the Wheels for Hope non-profit program, as an option to

use the surplus vehicles to help citizens. Ms. Boyce responded that donation requests from departments would be brought back before the Board for approval.

Referencing Attachment 1- 2013 Surplus Vehicle Listing, Commissioner Jacobs questioned the reason that vehicles labeled in "good" condition were deemed surplus and scheduled for removal/disposal. She then asked if there were plans to replace the vehicles on the list. Ms. Boyce responded stating that prior to a vehicle being labeled as surplus, departments were required to follow the Durham County Vehicle/Equipment Replacement Policy. She stated that the policy listed the criteria for a vehicle to be deemed surplus: mileage, age, repair costs and/or a lack of replacement parts or components. Ms. Boyce stated that the policy was applied to each vehicle before it was referred to her to be labeled as surplus. Commissioner Jacobs inquired if at any time surplus vehicles were referred to other departments that were in need of a vehicle. Ms. Boyce stated that before a vehicle is deemed to be surplus that the needs of other departments were considered; however once a vehicle meets the replacement criteria that it is usually not transferred to prevent further maintenance and repair costs.

Commissioner Reckhow moved, seconded by Vice-Chair Howerton, to approve the Resolution Authorizing an Electronic Public Auction Sale and authorize the County Manager or designee to follow the surplus disposal procedures for proper disposal and removal of accumulated surplus vehicles.

The motion carried unanimously.
