### 5. Resolution - Supporting the Increase of Social Security Benefits (5 min)

- 1) The Board is requested to approve this resolution calling on Congress to approve proposed legislation titled "Strengthening Social Security Act of 2013" co-sponsored by Senator Tom Harkin and Rep. Linda Sanchez. Primarily, the intent of the legislation is to increase the benefit funding formula for beneficiaries.

# 6. Acceptance of the Gold Greater Triangle Stewardship Development Award for the Durham County Justice Center and Parking Deck (5 min)

1) The Board is requested to accept the Gold Greater Triangle Stewardship Development Award for the Durham County Justice Center and Parking Deck presented to the County on April 22, 2014.

- 2) The Greater Triangle Stewardship Development Awards program honors development projects in the Greater Triangle area that demonstrate outstanding environmental stewardship through protection, conservation, improvement, and awareness of natural resources and community values. The Gold Level award is the highest recognition under this program.
- 3) Projects are judged on 8 criteria including Water Quality Protection, Vegetation Protection & Enhancement, Green Building, Integration with the Community, and Community Outreach & Education.
- 4) In conferring the award, the judging panel noted, "(a)s this decision indicates, the judges felt that the Courthouse project demonstrated exceptional achievement on all applicable GTSDA criteria, particularly our Outreach & Education and Green Building criteria.
- 5) The judges were impressed by the aesthetically pleasing integration of green features in all aspects of the facility, such as the green roof, which confers stormwater benefits as well as a "living systems" or biophilic connection, for building occupants.
- 6) <u>Alignment with Strategic Plan</u>: This aligns with Goal 4 Environmental Stewardship through the improvement of the environmental performance of County buildings to reduce energy use and greenhouse gas emissions from the built environment and improve water quality.
